How many measures have been notified?

Regular = 19,398 Emergency = 2,757. Addenda = 6,726. Corrigenda = 576. Translation supplement = 19. Recognition of equivalence = 7.

→ Total (all) = 29,485. (Regular + emergency = 22,155)

How many specific trade concerns (STCs) have been raised?

Specific Trade Concerns = 632 = 2.14% of notified measures.

"Full" (non-lapsed etc) disputes = **0.08**% of notified measures; all disputes = **0.17**% of notified measures "Full" (non-lapsed etc) disputes = **3.96**% of concerns raised in the committee; all disputes = **9.5**% of concerns (>90% never become disputes)

How many measures have been notified?

Regular notifications = 32,136. Revisions = 495. Addenda/Corrigenda/Supplements = 11,100

→ Total = **43,731**

How many specific trade concerns (STCs) have been raised?

Specific Trade Concerns = 701 = 1.6% of notified measures

"Full" (non-lapsed etc) disputes = **0.05**% of notified measures; all disputes = **0.13**% of notified measures "Full" (non-lapsed etc) disputes = **3.4**% of concerns raised in the committee; all disputes = **8.1**% of concerns raised in the committee (≈92% never become disputes)

Dispute settlement is not essential for the WTO to work (but it helps)

Less than 0.2% of SPS and TBT measures notified to the WTO end up as disputes. Less than 2% are raised as concerns in the SPS and TBT committees and 90% of those never become disputes.

Disputes involving SPS and TBT agreements

These are all the disputes citing the SPS and TBT agreements. There are two types of count:

- all cases including cases that never became "full" disputes
- those that are actively proceeding at least to a panel ruling, and in many cases to appeal.

Fully-fledged ("full") disputes exclude those that do not complete the panel stage. They have been withdrawn, a mutually agreed solution is reached before completing the panel stage ("settled out of court"), the authorisation to set up a panel has lapsed, or the case has stayed in the initial "request for consultations" stage for at least five years and can be considered to be "dormant". They are listed without numbering and the reason for considering them to have lapsed or to be non-active is highlighted.
